Commission Open Meeting

Immediate Release

(Washington, D.C.) The proposed agenda for the Commission Open Meeting was posted in the Commission's Secretary Office and on the Commission's website on Monday, April 30, 2018, and amended Tuesday, May 1, 2018, rescheduling the Open Meeting to Friday, May 4, 2018, and proposed to be further amended to remove [Formal Case No. 1142](#) from the agenda. The Commission received a motion at 10:43 a.m. to hold the proceeding in abeyance. The Commission will take the motion under advisement and will remove this matter from the agenda.

Today, there are two action items before the Commission. The matters are:

1. [Formal Case No. 1150, In the Matter of the Application of Potomac Electric Power Company for Authority to Increase Existing Retail Rates and Charges for Electric Distribution Service and Formal Case No. 1151, In the Matter of the Impact of the Tax Cuts and Jobs Act of 2017 on the Existing Distribution Service Rates and Charges for Potomac Electric Power Company and Washington Gas Light Company.](#) This Order grants the Joint Motion to Suspend the Procedural Schedules in Formal Case Nos. 1150 and 1151 filed by the Potomac Electric Power Company ("Pepco"), the Office of the People's Counsel for the District of Columbia, the Apartment and Office Building Association of Metropolitan Washington, the District of Columbia Government, the Maryland DC Virginia Solar Energy Industry Association, D.C. Climate Action, Baltimore-Washington Construction and Public Employees Laborers' District Council, Tesla, Inc., Small Business Utility Advocates, and DC Consumer Utility Board and Solar United Neighbors. The Commission also adopts the revised procedural schedule set out in this Order and grants Pepco's Motion to Withdraw Filing[s] and Consolidates Formal Case Nos. 1150 and 1151.
2. [Consumer Complaint 2017-9075230, Gerald Henneghan v. Potomac Electric Power Company.](#) This Order affirms the Hearing Officer's March 8, 2018, decision dismissing this case with prejudice. Any party affected by this decision may file a request for reconsideration within 30 days of the issuance of the decision
